Each year, tourism brings in revenue to the Greater Burlington Region, creating a "second holiday season" for retailers at Maple Tree Place. Inland Western Retail Real Estate Trust, Inc., a self-administered, publicly registered, non-listed real estate investment trust sponsored by an affiliate of The Inland Real Estate Group, owns the center and handles leasing and management.
